

Privacy Policy

Introduction

This Policy sets out how BursaryNetwork makes use of and protects any personal information that you give us when you use our website, www.BursaryNetwork.com, and any associated applications. We may change this Policy from time to time by updating this page. You should check this page from time to time to ensure you are happy with any changes. By accessing any part of this website or providing information to us you consent to the use and transfer of such information by us on the terms set out in this Policy.

Information Collected from You

When you use www.BursaryNetwork.com, we may ask you to provide certain data, such as your contact details, banking details, demographic information, employment and educational history and, in the case of Company Representatives seeking to raise capital through the BursaryNetwork platform, information about your business. We may supplement the information you provide us with information we receive from third parties. We may also collect the following information:

- Information that you provide to us when you write to us (including by email).
- Information that you provide to us when we speak to you by telephone. We may make and keep a record of the information you share with us.
- Information that you provide to us by completing surveys.
- Details of transactions you carry out through the BursaryNetwork platform.

Uses of the Information Collected

Information stored about you is used in the following ways:

- To confirm your identity in order to create the donor account and ensure that you are eligible to use the services provided on www.BursaryNetwork.com.
- To provide you with information on selected products and selected services that we think may be of interest to you (unless you have asked us not to do so)
- In the case of students looking to raise funds on www.BursaryNetwork.com, to verify and approve the information given to the potential donors.
- To monitor, improve and administer the Website and the services provided on the Website.
- To enable us to comply with our legal and regulatory obligations.
- To carry out our obligations arising from any contracts entered into between you and us.
- To notify you about changes to our goods and services.

Information We Will Not Share

We will not share the information gathered from you to third parties except in the ways disclosed in this policy. We treat the information given to BursaryNetwork and its affiliates as confidential. We do not sell your information to third parties.

- We may disclose your personal information to any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries.
- We may provide your personal information to companies that provide services to help us with our business activities such as processing payments, offering customer services or to improve our business operations. These companies are authorized to use your personal information only as necessary to provide these services to us.

- If you have made a donation or applied to make a donation to a student through www.BursaryNetwork.com, your personal information will not be disclosed to the student (or the student's institution).
- We may disclose certain of your personal information if we are required to do so by law, regulation or order of court or other legitimate government body or arbitration panel. This includes, among other things, any information that may be requested by the South African Revenue Services.
- In the event that we intend to enter into a major corporate transaction, such as a sale of control of our or another business on a stock exchange, we may disclose some of your information to potential buyers, underwriters or advisors. If we do this, we will take reasonable precautions to ensure that the recipients of your personal information are obligated to keep it confidential.

Change of Business Ownership or Control

BursaryNetwork may, from time to time, expand, reduce or sell our business, and this may involve the transfer of certain divisions or the whole business to other parties. Your personal information will, where it is relevant to any division so transferred, be transferred along with that division and the new owner or newly controlling party will, under the terms of this Privacy Policy, be permitted to use your personal information for the purposes for which it was supplied by you.

Securing your Personal Information

In using www.BursaryNetwork.com, you accept the inherent security implications of engaging in transactions online over the internet, and you agree that you will not hold us responsible for any breach of security unless we have been grossly negligent or in wilful default.
